# GOLF CLUB MEMBERSHIP AGREEMENT

## CONSUMER'S RIGHTS TO CANCELLATION

**YOU MAY CANCEL THIS AGREEMENT WITHOUT PENALTY OR FURTHER OBLIGATION WITHIN THREE (3) DAYS FROM THIS DATE.** Notice of cancellation shall be in writing and delivered or mailed to the Seller by registered or certified United States mail. Such notice shall be accompanied by your copy of this Agreement and any evidence of membership previously delivered to the Buyer. All monies paid pursuant to this Agreement, including initiation fees, shall be refunded within fifteen (15) business days of receipt of such notice of cancellation. If the Buyer has executed a credit agreement to pay for all or part of any Golf Club services, such agreement executed by the Buyer, shall also be returned to Buyer within fifteen (15) days. Notice of cancellation shall be sent to the Golf Club at Chelsea Piers, Chelsea Piers - Pier 59, New York, NY 10011, Attention: Membership.

## Additional Rights to Cancellation Within the First Twelve (12) Months

You may also cancel this Agreement at any time (subject to cancellation fee) for any of the following reasons:

- If upon a doctor's order you cannot physically receive the services provided by the Golf Club because of significant physical disability for a period in excess of six (6) months (you must provide doctor's written note).
- If you move your residence more than twenty-five (25) miles from the Golf Club (you must provide proof of residence). If your residence is currently more than seventy-five (75) miles from the Golf Club, you must provide proof of a change of residence from your current address.

All monies paid, excluding the initiation fee, pursuant to this Agreement contract canceled for the reasons contained in this subdivision, shall be refunded within fifteen (15) days of receipt of such notice of cancellation provided above; provided, however, that the Seller may retain the expenses incurred and the portion of the total price representing the services used or completed, and further provided that the Seller may demand the reasonable cost of goods and services which the Buyer has consumed or wishes to retain after the cancellation of this Agreement. In no instance shall the Seller demand more than the full contract price from the Buyer. If the Buyer has executed a credit agreement to pay for all or part of any Golf Club services, such agreement shall also be returned within fifteen (15) days.

## DUES AND CHARGES

All membership options require a one-time initiation fee of \$75 at the time of purchase. Monthly dues and charges shall be paid through electronic deduction from the Member's checking account or by electronic charges against the Member's designated credit card. Members can expect monthly payments for the current month's dues and prior month's charges to be deducted or charged no later than the eighth business day of the month. In the event that a member's designated credit card expires, the Golf Club reserves the right to continue billing the designated credit card until updated billing information is received or written cancellation notice is received per the terms outlined below (see "TERM"). The monthly rate for dues shall be subject to change at any time by the Golf Club, provided that the Golf Club agrees to charge you the monthly rate applicable today for at least the period ending twelve months after the date of this Agreement or such other period as applies under any applicable promotional or corporate program.

## DISHONORED CHECK OR DRAFT

If any payment of dues or other charges is not made on time, the Golf Club reserves the right to terminate membership. Member agrees to pay all costs incurred to enforce collection including, but not limited to, attorney's fees and administrative costs. Additionally, for each check or draft for outstanding balances payable to the Golf Club not honored, the Golf Club will assess a \$25 service charge.

## TERM

**12-MONTH EFT MEMBERSHIP:** EFT Memberships may be terminated at any time after the initial term (12-months) with a minimum thirty (30) days notice by fully completing and submitting the Cancellation Request Form by certified or registered mail, email or fax to the Golf Club.

**12-MONTH PAID-IN-FULL MEMBERSHIP:** The term of the membership shall be for an initial minimum period of twelve (12) paid full months, after which time the membership will expire unless renewed before the date of expiration.

## ACKNOWLEDGMENT OF RISK AND RELEASE OF LIABILITY

The Member understands that there is an inherent risk associated with the use of the Golf Club facilities, equipment and programs, that may result in an injury to the Member. Therefore, the Member assumes full responsibility for any injury or damages to the Member or Member's guests in, on or about the Golf Club premise and does hereby and forever release and discharge Chelsea Piers Management, Inc., the Golf Club, its owners, employees, and agents from any and all claims, demands, damages, rights or causes of action, present and future, whether the same be known or unknown, anticipated or unanticipated, resulting from or arising out of the Member and the Member's guests use, or intended use, of the facilities, equipment and programs.

## MEMBERSHIP BYLAWS **All members agree to abide by the rules and regulations set forth by the Golf Club at Chelsea Piers and any such amendments or additions as the Golf Club Management deems necessary.**

**NONDISCRIMINATION STATEMENT** The Golf Club at Chelsea Piers will accept applications for membership from any individual, couple or family of good character and responsible credit background without regard to race, creed, color, handicap status, sex, sexual preference or national origin. Memberships are available to all individuals 16 years or older.

**MEMBERSHIP IDENTIFICATION AND CHECK-IN** All members must present a valid membership card when paying for merchandise, tee time or lessons. A fee of \$10 will be charged to replace a lost card. Furthermore, membership cards are issued to members only and are non-transferable. A member authorizing improper use of membership cards will have his or her membership terminated immediately.

**CLUB ETIQUETTE** Proper clothing is required. There is no smoking in or around the facility. Consideration and courtesy of fellow members and employees is expected. Foul language and abusive behavior will not be tolerated.

**FREEZING MEMBERSHIP** Members may freeze their membership for medical reasons at no charge, once per calendar year for a period no longer than 90 consecutive days (member must provide a doctor's written note or letter from supervisor on business stationary). The Golf Club requires a minimum of fifteen (15) days advance notice.

**LOCKER POLICY** Masters and Platinum Members will be provided locker assignments and a key. The Golf Club is not responsible for any items stored in the lockers, and member agrees that any personal property or valuables left at the Golf Club is at his or her own risk. There will be a \$10 replacement charge for lost keys.

**GUEST RESERVATION POLICY** Masters and Platinum Members are allowed 10 and 20 Guest Reservation Privileges, respectively, each year. Each individual guest is limited to two visits to the club per year. Members are limited to bring a maximum of two guests per visit to the club. Guest Reservation privileges do not carry over year to year.

**ADVANCED STALL RESERVATIONS** Masters and Platinum Members are allowed advanced hitting stall and full swing simulator reservations. Members must check in with the front desk staff prior to play. Members must allow a minimum of two hours for advanced reservations. Reservations are based on availability, as the Golf Club reserves the right to close the facility as needed. We will hold your reservation for 15 minutes beyond desired start time, after which, your reservation will be released. Please notify us if you cannot make your reservation.

**CONVERSION/UPGRADE POLICY** Members have a 30-day period to convert the Membership Contract and Agreement and upgrade the membership classification. All previous payments will be applied toward the converted or upgraded membership.

**LOST AND FOUND** The Golf Club is not responsible for any lost or stolen items, and member agrees that any personal property or valuables left at the Golf Club is at his or her own risk. This includes bicycles locked outside the Golf Club facility. The Golf Club Management advises all members not to bring expensive items or large sums of money to the Golf Club.

**CHANGE OF CONTACT INFORMATION** All members must notify the Golf Club in writing of any phone, mailing, email or office address changes.

**DAMAGES** Any damage to the Golf Club property by a member, member's children or guests shall be the responsibility of the adult member.

**GOLF CLUB'S RIGHT TO REVOKE MEMBERSHIP** The Golf Club Management may revoke membership in the event the member violates the provisions of the Membership Agreement, bylaws or for undesirable behavior, as determined by the Golf Club Management. If the Golf Club Management revokes a membership, the member must submit all the Golf Club identification and their signed agreement to the Golf Club.

**BAG AND CLUB STORAGE** Bag and Club Storage is for active Masters and Platinum Members only. Members may keep their clubs in storage for up to ten business days past their expiration date. After that, a \$75 charge will be assessed for each month the bag remains in storage and charged to the credit card on file.

**The Golf Club bylaws are not inclusive and may be amended or added to as Management deems necessary. The Golf Club Management reserves the right to post house rules (see attached). Such rules will be deemed to be incorporated by reference to the bylaws, and remain in effect so long as such house rules remain posted.**

## GOLF CLUB HOUSE RULES

- Play at your own risk. Play safely and within your ability.
- Practice swings are allowed only in front of the green column and on tee mat.
- Do not attempt to hit balls at ball picker.
- Do not hit irons off the tee. Please use hitting mat.
- Only one person in a stall at a time.
- Golfers must stay behind the yellow safety line at all times.
- The Golf Club is a non-smoking facility. There is no smoking anywhere on the premises.
- No alcoholic beverages are allowed on the tee line.
- Please observe a proper dress code – shoes and shirt must be worn at all times.
- Golfers must yield stall to members or groups with a reservation.
- Management is not responsible for lost or stolen belongings.
- Unchaperoned children under 16 years of age are not allowed in the facility. No children are allowed on Levels C or D.
- No strollers allowed on tier levels.
- Bikes and pets are not allowed on the premises.
- Do not tamper with tee up equipment. Ask for assistance from a Golf Club representative or hit your call button.
- No patron is permitted to instruct another patron.
- Management reserves the right to withdraw golfing privileges of patrons who are disruptive and/or fail to follow the House Rules.
